Montana reported that Fire Departments are not available to water Wickham Park arena since doing so would take a truck out of service. She will continue to research other options but it is likely that we will not find a watering solution.

NEW BUSINESS

2026 Show Season

The January show was cancelled out of caution for the health of our equine community. This initiated a discussion of how to proceed.

Three options were discussed:

1. Convert to 3 show series (February, March April with Year End Awards like last year. Requirement for class grand/reserve award: 2 scores earned at two different shows.
 - a. This option will require a Year End Committee to plan, organize, and execute all activities relative to series winners recognition.

2. Continue with planned Championship approach with February, March and April shows as scheduled with Championship Classes offered at April Show? Modify championship requirements to ONE score.
3. Shift Championship approach to end of year or run 2 shows at end of year and 2 shows at beginning of 2027.

After discussing pros and cons of all options, the members voted for Option #1. The current schedule for the three shows will stand. This decision will require an update to the website. Lindsey will post notices to Facebook pages. Barb will update Prize List. Barb will deliver DHD owned laptop and printer to Sandy. Annie will help Sandy get set up to receive .org emails for show secretary. A committee will be solicited to plan, organize, and execute series winners recognition.
